

## Authorization for the Burial at Sea of Cremated Remains

I/We understand that once the remains of the Deceased are disseminated, they are unrecoverable. Unless otherwise specifically provided for herein, once dissemination of cremated remains of the Deceased has been performed, **Monterey Bay Boat Charters** reserves the right, at its sole discretion, to dispose of the container which contained said cremated remains.

I/We agree to release and hold **Monterey Bay Boat Charters**, its affiliates and their agents, employees, successors and assigns harmless from any and all loss, damage, liability or causes of action (including attorney's fees and expenses of litigation) in connection with the disposition of the cremated remains of the Deceased as authorized herein or respect to the Identification of said remains as being of the Deceased.
